**1-Definition of Administrative Law:** is the body of legal rules that indicate the administrative authorities in the state in terms of their composition and activities, as public authority possessing special rights and privileges in their relations with individuals.

**2- Administrative custom:** Administrative custom is the set of rules that the administration is accustomed to following in performing it's function in a specified field of it's activity in the absence of a legislative text that

regulates this activity, so it becomes bending on it and violating it is considered a violation of legitimacy
